



One Person One Record – Clinical Information System (OPOR-CIS): MyExperience

This short guide is intended to provide information on the feature of **MyExperience** within the One Person One Record Clinical Information System (OPOR-CIS).

MyExperience

MyExperience is a functionality within the CIS that enables providers, residents, and medical students working within various specialties to switch between various viewpoints of the CIS with only one login credentials.

For example, a medical student switching from an emergency medicine clinic to a critical care can use the MyExperience function to switch their CIS viewpoint to that of a critical care physician without having to log out nor change their login credentials.

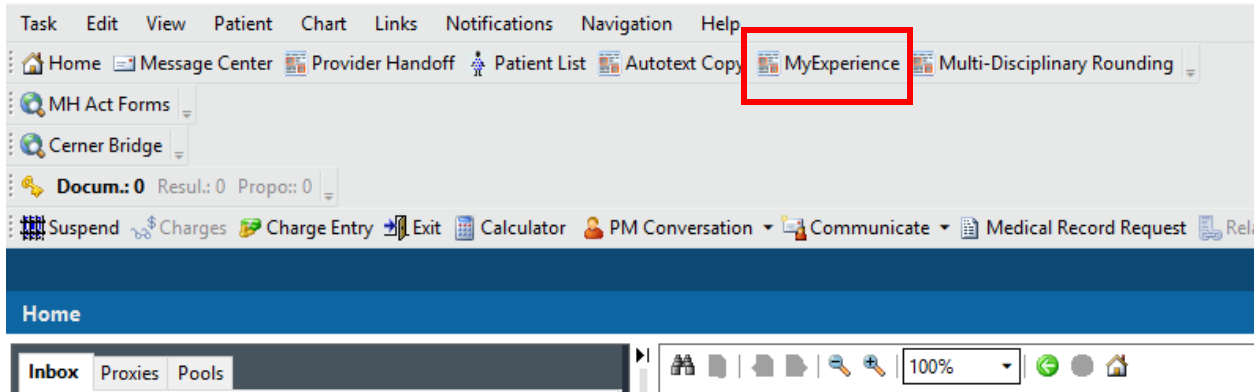
Key Benefits

In previous state, the previously mentioned medical student would have different log in credentials for each of their rotations. A physician covering for another would have to login using a different credential. A resident would have to juggle a list of credentials for each rotation. However, MyExperience eliminates the need for juggling multiple credentials and speeds the process of switching roles.

- Enables provides to quickly switch between specialties, as required for a provider working within multiple specialties, covering another provider, or students and residents transitioning between rotations and clinics.
- Improvement in user experience – minimizes the need to log in and out of the system.
- Flexibility – especially if role changes are time sensitive.
- Helps prevent missed tasks, orders, messages, and other responsibilities given that the user retains one account and role profile throughout specialties.

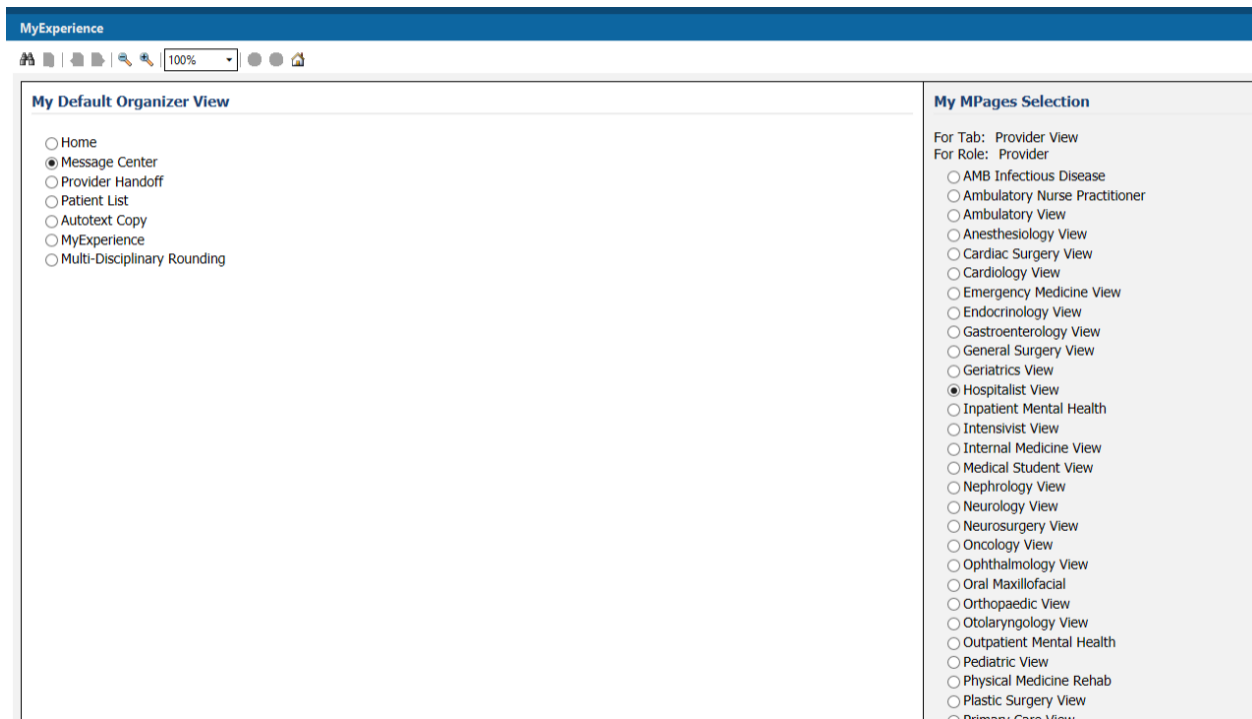
How to Use MyExperience in the CIS

Once a user logs into the CIS, the “MyExperience” will be on the top banner, as shown in the following image.

Once the user clicks on the “MyExperience” button, a two-panelled page appears, shown in the image below. Only the right panel is relevant for our purposes, titled “My MPages Selection”. This panel lists the possible specialties in between which the provider can switch and the user is prompted to select their preferred viewpoint. In the example below, the user has selected the “Hospitalist View”.

Please note that MyExperience is only used to switch between specialties or care areas **when a provider does not require additional privileges to enter the new specialty**. While most providers will most likely use MyExperience to switch between specialties, **nurses and other clinicians with multiple roles would probably use another functionality referred to as Role Profiles**.
